Founded in 2010, the GALS Middle School serves 6-8th grade students. We have 326 students from all corners of Denver. The GALS Denver High School, founded in 2014, serves approximately 133 9th-12th grade students. Our students are honing their leadership skills (both inside and outside of the classroom) to go out and make a positive difference in the world. The Boys School of Denver opened its doors in 2017 and offers 6th and 7th grades this year. The full build-out
