Founded in 2010, GALS Middle School serves 6-8th grade students. Enrollment FYE 6/30/23 totaled 187 students. The GALS Denver High School, founded in 2014, serves 9-12th grade students. Enrollment FYE 6/30/23 totaled 98 students. Both schools are enriched by the diversity of the student population which provides unique cross cultural learning opportunities. The expansive educational goals of GALS Denver require that we focus our financial

priorities around our classroom teachers and student support specialists. Salaries and benefits comprise 73% of the annual budget, which supports a very favorable teacher per pupil ratio of 12:1. Some highlights from our year include:

- Math growth from fall to spring was close to double the national average.

- In all but one area of Middle School, our CMAS proficiency scores outpaced DPS proficiency scores.
